## **Executive Summary**

Public Works is requesting approval of the Renewable Power Purchase Agreement, "The Solar PPA" (Second Amendment), between Evergy and City of West Plains for the Solar Facility.

#### Discussion

This Renewable Power Purchase Agreement Second Amendment (the "Second Amendment") is entered by and between the City of West Plains, Missouri and Evergy Kansas Central, Inc. (f/k/a Westar Energy, Inc.) to that certain Renewable Power Purchase Agreement between the Parties dated August 19, 2019, and as previously amended on May 20, 2020 (the "Solar PPA").

Exhibit A outlines the specifications for the Solar Facility if Evergy maintains an investment grade credit rating of at least BBB will be able to self-insure to the extent of the insurance requirements.

## Fiscal Impact

The City will purchase the energy from the Solar Facility in accordance with the PPA. This agreement identifies the need for self-insured on the facility at Evergy's cost and this agreement adds no other additional expense.

# SECOND AMENDMENT TO THE RENEWABLE POWER PURCHASE AGREEMENT

This Second Amendment (the "Second Amendment") is entered into this \_\_\_\_\_day of January, 2022, by and between the City of West Plains, Missouri ("Buyer") and Every Kansas Central, Inc. (f/k/a Westar Energy, Inc.) ("Seller") (together, the "Parties"), to that certain Renewable Power Purchase Agreement between the Parties dated August 19, 2019, and as previously amended on May 20, 2020 (the "Solar PPA").

WHEREAS, the Parties have heretofore entered into the Solar PPA, as amended; and

WHEREAS, the Parties wish to further amend the Solar PPA to permit Seller to meet its insurance obligations through self-insurance if certain conditions are met.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements herein set forth, the parties do hereby agree as follows:

## 1. Amendment to Section 4.1(iv)

Amend Section 4.1(iv) by adding the following sentence at the end of the subsection:

"Notwithstanding the foregoing, so long as Seller maintains an investment grade credit rating of at least BBB- with Standard & Poor's Rating Group or Baa3 with Moody's Investor Services, Inc., Seller may elect to self-insure to the extent of the insurance requirements set forth in Exhibit B without approval by Buyer; provided, however, in the event of any destruction or all or any part of the Generating Facility during a period where the Seller elected to self-insure, Seller shall remain obligated to reconstruct the Generation Facility or the affected portion unless Seller can demonstrate to Buyer that it is not commercially reasonable to do so."

## 2. Miscellaneous

(a) Entire Agreement. Each reference to the Solar PPA appearing in any document shall be deemed a reference to the Solar PPA as amended effective as of the execution date of this Second Amendment. Except as amended by the provisions set forth in this Second

Amendment, all other items and conditions of the Solar PPA shall remain in full force and effect following the execution of this Second Amendment.

- (b) **Counterparts.** This Second Amendment may be executed in any number of counterparts with the same effect as if all signatures were upon the same instrument.
- (c) **Defined Terms**. Capitalized terms not otherwise defined herein are as defined in the Solar PPA, as amended.
