## Dumpster Rental Guidelines and Fees

**4-Yard:** \$41.20 each time emptied+ \$2.06 per day rent (5'w X 7'1 X 4'd) w/\$40 Deposit

**6-Yard:** \$61.80 each time emptied+ \$2.06 per day rent (5'w X 10'1 X 4'd) w/\$60 Deposit

**20-Yard & 30-Yard Roll-off Containers:** \$51.50 set up fee+ \$103.00 each time emptied+ \$4.12 per day rent +\$60 per ton w/\$200.00 Deposit

- Dry Run Fee (dumpster inaccessible, overfilled and/or unacceptable items) - \$51.50
- Fee to relocate and/or move dumpster \$51.50

**Not Acceptable in 4-Yard and 6-Yard dumpsters:**

- Absolutely NO chemicals, paint, stains, hazardous or special/regulated wastes, oil, or liquids
- Automotive (i.e., lead/acid) batteries
- Concrete, bricks, blocks, rocks, etc.
- Heavy pieces of metal (e.g., I-beams, structural steel, automobile motors, etc.)
- Heavy remodeling debris (e.g., ceramic tile, roofing shingles, etc.)
- Long pieces of pipe, angle iron, or tubing (3 feet or less are acceptable)
- Tires and major appliances (e.g., washer, dryer, stove, refrigerator, water heater, dehumidifier, etc.)
- Yard Waste (e.g., grass clippings, leaves, tree limbs, etc.)

**Not Acceptable in 20 or 30-Yard dumpsters:**

- Absolutely NO chemicals, paints, stains, hazardous or special regulated wastes, oil, or any liquids
- Automotive batteries (i.e., lead/acid) batteries
- Tires and major appliances (e.g., dehumidifier, dryer, refrigerator, stove, washer, water heater, etc.)
- Yard waste (e.g., grass clippings, leaves, tree limbs, etc.)

**If used for concrete, dirt, rock, etc. a 20-yard is the MAXIMUM size allowed.**

**TERMS AND CONDITIONS:**

- 1) Customers are prohibited from moving dumpsters with heavy equipment and will be held liable for damage to dumpsters. Please call the office (phone number?) to have the dumpster moved or relocated.
- 2) Dumpsters must not be overfilled. Waste protruding above the top will prevent emptying.
- 3) Large slabs or chunks of concrete are not acceptable.
- 4) Customer assumes responsibility for any property damage (e.g., to the lawn or paved surfaces) resulting from the placing or removal of a dumpster as requested by the customer or representative.
