ORDINANCE NO. 4746

AN ORDINANCE OF THE CITY OF WEST PLAINS, MISSOURI TO AMEND AND REPLACE THE FOLLOWING FOUR EXISTING SECTIONS OF THE CITY CODE:

CHAPTER 4, ALCOHOLIC BEVERAGES, SECTION 4-20 APPROVAL OF APPLICATION, SECTION 4-23 (a) SALE ON PREMISES OF CHARITABLE, FRATERNAL, RELIGIOUS, SERVICE OR VETERANS' ORGANIZATIONS, SECTION 4-29 ISSUANCE, AND 4-41 PREREQUISTES FOR RENEWAL.

WHEREAS, it has been determined by the City Council of West Plains, Missouri, that the welfare of the residents of the City of West Plains will be promoted by amending and replacing the above sections of the existing City Code of West Plains, Missouri, and

WHEREAS, it is necessary to enact an ordinance amending and replacing the above sections of the existing City Code of West Plains, Missouri, to promote the welfare of the residents of the City of West Plains, Missouri.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST PLAINS, MISSOURI, THAT THE FOLLOWING SECTIONS OF THE CITY CODE ARE AMENDED AND REPLACED AS FOLLOWS:

Chapter 4 – ALCOHOLIC BEVERAGES

Section 4-20. – Approval of application.

All applications for a license required under this chapter shall be approved by either the City Administrator or City Clerk after the applicant has complied with all city and state requirements.

Section 4-23. – Sale on premises of charitable, fraternal, religious, service, veterans' organizations or civic group.

- (a) Any charitable, fraternal, religious, service, veterans' organization which has obtained an exemption from the payment of federal taxes as provided in section 501(c)(3), 501(c)(4), 501(c)(5), 501(c)(7), 501(c)(8), 501(c)(10), 501(c)(19), or 501(d) of the Internal Revenue Code, as amended, or civic organization desiring to sponsor a special event that will promote the City of West Plains and surrounding area, and which has been issued any required state license to sell intoxicating liquor by the drink pursuant to the provisions of the Revised Statutes of Missouri and which otherwise meets the requirements of and complies with the ordinances of the city may apply for, and the city may issue, a license to sell intoxicating liquor, as defined in Section 4-2 above, by the drink at retail for consumption on the premises.

Section 4-29. – Issuance.

Upon the approval by the City Administrator or City Clerk, the City Clerk shall have authority to issue the licenses required by this chapter.

Section 4-41. – Prerequisites for renewal.

Before the City Administrator or City Clerk renews a liquor license issued under this chapter, the license compliance board shall determine if the applicant has complied with the laws of the city pertaining to liquor establishments. If the license compliance board determines that the applicant has failed to comply with the laws of the city, the City Administrator or City Clerk shall not issue the license and shall notify the applicant pursuant to Section 4-38.

This Ordinance shall be in full force and in effect after the date of its passage and approval.
