ORDINANCE NO. 4756

AN ORDINANCE OF THE CITY OF WEST PLAINS, MISSOURI TO ADD THE FOLLOWING SECTION TO THE CITY CODE:

CHAPTER 2, ADMINISTRATION, ARTICLE IV – BOARDS, COMMISSIONS, COMMITTEES AND COUNCILS, DIVISION 10. – AIRPORT ADVISORY BOARD SECTION 2-299 APPOINTMENT, SECTION 2-300 SELECTIONS AND TERMS, SECTION 2-301 SELECTION OF OFFICERS, 2-302 RECOMMENDATIONS.

WHEREAS, it has been determined by the City Council of West Plains, Missouri, that the safety and welfare of the residents of the City of West Plains will be promoted by adding the above sections to the existing City Code of West Plains, Missouri, and

WHEREAS, it is necessary to enact an ordinance adding the above sections to the existing City Code of West Plains, Missouri, to promote the safety and welfare of the residents of the City of West Plains, Missouri.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST PLAINS, MISSOURI, THAT THE FOLLOWING SECTIONS BE ADDED TO THE CITY CODE AS FOLLOWS:

Chapter 2 - ADMINISTRATION

Article IV - BOARDS, COMMISSIONS, COMMITTEES, AND COUNCILS

Division 10 - Airport Advisory Board

Sec. 2 - 299. - Establishment and how Appointed

There is created an airport advisory board to consist of three patrons of the West Plains Municipal Airport along with one member of the city council. Members of the airport advisory board shall be appointed by the mayor and each appointment shall be confirmed by the city council.

Sec. 2 - 300. - Terms

The term shall be for three years with the initial board serving staggered terms of one, two, and three years so that one non-city council member's term shall expire each year. The city councilperson serving on the board shall always serve a one-year term.

Sec. 2 - 301. - Officers

The board shall annually select one of its members to serve as president and one of its members to serve as secretary. The city council member serving on the board shall not serve as an officer.

Sec. 2 - 302. - Recommendations

The board shall meet at least quarterly with meetings to be held in person, by phone, or virtually

at a location to be selected by the board members. The board shall provide recommendations, advice, and feedback to the city administrator and city council regarding ways to promote the use, safety, development, and efficient operation of the airport.

This Ordinance shall be in full force and in effect after the date of its passage and approval.
