Executive Summary

Recommending an ordinance approving the vacation of a 10' alley between Broadway and 1st Street.

Discussion

This request has been submitted by Moira Seiber, Terry Johnson, and John Harris. This request is for vacating an alley between the three adjacent parcels to facilitate additional parking in the area.

The city will retain an easement for the maintenance of existing utilities.

AN ORDINANCE VACATING AN ALLEY BETWEEN WEST BROADWAY AND WEST 1ST STREET UPON THE REQUEST OF ADJACENT PROPERTY OWNERS - JOHNSON, SEIBER, AND HARRIS AND FURTHER RETAINING A UTILITY EASEMENT WITHIN THE AREA TO BE VACATED.

WHEREAS, a petition has heretofore been filed by Terry Johnson, Moiria Seiber, and John Harris to vacate an alley generally located between West Broadway Avenue and West 1st Street. Petitioners state that said alley is not needed for use as such by the public, and that the property rights of others in the adjacent areas are not affected in the vacating of said alley further described as follows:

All that part of the alley within Block 6 of Foust's Addition, Section 21, Township 24, Range 8 as shown to the City of West Plains as recorded in the records of Howell County, Missouri; and

WHEREAS, the city will retain a utility easement for the sake of maintaining any and all utilities within the area described above; and

WHEREAS, a public hearing was held on May 2nd, 2024, and notice of said hearing was published in the West Plains Quill on April 10th, 2024; and

WHEREAS, the Planning Commission recommended in favor of the vacation and the City Council finds that it would be appropriate to vacate the alley described above provided that a utility easement is retained by the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST PLAINS, MISSOURI AS FOLLOWS:

Section 1: That the above-described alley is hereby vacated but reserving to the City of West Plains a utility easement within the area to be vacated for the purpose of installation, maintenance and reconstruction of utility lines, pipes and related facilities.

<u>Section 2:</u> That this Ordinance shall be in full force and effect ten days after its date of passage and approval as provided by law.
