



## **Dumpster Rental Guidelines and Fees**

4-yard: \$42.85 each time emptied + \$2.14 per day rent (5'w X 7'L X 4'd) w/\$40 Deposit

6-yard: \$64.27 each time emptied + \$2.14 per day rent (5'w X 10'L X 4'd) w/\$60 Deposit

20-Yard & 30-Yard Roll-off Containers: \$53.56 set up fee + \$107.12 each time emptied + \$4.28 per day rent + \$61.20 per ton w/\$200.00 Deposit

- Dry Run Fee (dumpster inaccessible, overfilled and/or unacceptable items) - **\$53.56.**
- Fee to Relocate and/or move dumpsters - **\$53.56.**

### **Not Acceptable in 4-yard and 6-yard dumpsters**

- Absolutely NO chemicals, paint, stains, hazardous or special/regulated wastes, oil or liquids
- Automotive Batteries (i.e., lead/acid)
- Concrete, bricks, blocks, rocks, etc.
- Heavy pieces of metal (I-beams, structural steel, automobile motors, etc.)
- Heavy remodeling debris (ceramic tile, roofing shingles, etc.)
- Long pieces of pipe, angle iron, or tubing (3 feet or less are acceptable)
- Tires and major appliances (dehumidifier, dryer, stove, refrigerator, washer, water heater, etc.)
- Yard Waste (grass clippings, leaves, tree limbs, etc.)

### **Not Acceptable in 20 or 30-yard dumpsters**

- Absolutely NO chemicals, paint, stains, hazardous or special/regulated wastes, oil or liquids
- Automotive (i.e., lead/acid) Batteries
- Tires and major appliances (dehumidifier, dryer, stove, refrigerator, washer, water heater, etc.)
- Yard Waste (grass clippings, leaves, tree limbs, etc.)

**If used for concrete, dirt, rock, etc. a 20-yard is the maximum size allowed.**

**Terms and Conditions**

- 1) Customers are prohibited from moving dumpsters with heavy equipment and will be held liable for damage to dumpsters. Please call the office at 417-256-7176 ext. 2720 to have the dumpster moved or relocated.
- 2) Dumpsters must not be overfilled. Waste protruding above the top will prevent emptying.
- 3) Large slabs or chunks of concrete are not acceptable.
- 4) The customer assumes responsibility for any property damage (e.g., to the lawn or paved surfaces) resulting from the placing or removal of a dumpster as requested by the customer or representative.
