Executive Summary

This is to purchase a paper shredder for the recycling department.

Discussion

We are recommending First Choice Destruction submitted the lowest bid at \$68,817. This investment will increase the price of recycling of paper from \$100 per ton to \$135 per ton for shredded paper, helping to increase profits. It will also provide a valuable community service by allowing residents and business to bring documents for shredding monthly. Additionally, City Hall, the Courts, and the Police Department will no longer need to contract out for document shredding services.

We currently have \$90,000 left from the purchase of an over the road truck this year and would like to purchase this from the money left.

I was able to speak with my sanitation director. Turns out we have a small recycling setup and are just starting to shred our own paper. We currently only have one baler. It is in the third picture.

It is from J.V. Manufacturing HE-60-M. We will only be offering paper shredding only one day a week, so we will be utilizing two people to man the shredder, so we will not need any hopper fill eyes. The paper we will be shredding will only be what is hand delivered to the facility. We won't be dumping anything from a truck. The first two pictures will be a general location for the shredder. 
