The West Plains City Council met in regular session on January 20, 2026, in the council chambers at West Plains City Hall, 1910 Holiday Lane, with the following members present: Councilmember Greg Collins, Councilmember Ron Grennan, Councilmember Johnny Murrell, Councilmember Jessica Nease, and Mayor Michael Topliff. Mayor Topliff led the invocation and Pledge of Allegiance.

- a. **Resolution 2026-01** – A resolution of the City of West Plains, Missouri, authorizing the mayor or city administrator to execute an agreement between the City of West Plains and Mandy’s Mobile Foods, LLC for concession rights. Councilmember Nease motioned to approve, seconded by Councilmember Murrell. Motion carried.
- b. **Resolution 2026-02** – A resolution of the City of West Plains, Missouri, to adopt a Transportation Safety Action Plan, *Vision Zero Transportation Safety Action Plan* to ensure the health, safety, and prosperity for bicyclists, pedestrians, transit riders, motorists, and other users of the transportation network, and its rights of ways in a manner that balances user needs and is consistent with the surrounding community. Councilmember Nease motioned to approve, seconded by Councilmember Collins. Motion carried.
