2. [Resolution 2026-15](#) – A resolution of the City of West Plains, Missouri, authorizing the submission of an application to the Delta Regional Authority (DRA) for funding through the States' Economic Development Assistance Program (SEDAP) for the City of West Plains First Street Workforce Parking Improvement project; designating the city administrator to serve as the city's authorized representative for all matters relating to the application and administration of the grant.
